

BONUS BREAKAWAY EVENT APPROVAL DETAILS

Please read carefully as the requirements for 2024 have changed!

Requirements: NOMINATION FEES

*All entries must pay \$10 Bonus Breakaway Nomination Fee 1x (The only exception would be men or boys that will be over the age of 14 as of Jan 1, 2024). Those should be noted on the results sheet as "Not Eligible". All other entries are required to PAY the \$10 per roper nomination fee. (Note the nomination fee is paid back 100% at the BRWF we do not hold out any fees for administration)

HOW TO AWARD QUALIFIERS AT YOUR EVENT:

An application must be submitted 30 days prior to the event. We NORMALLY process paperwork on the 1st and 15th of the month. A google docs form can be submitted online or a form can be emailed/mailed in. bbbarrelbash@yahoo.com

Once approved, you can advertise your event using the Bonus Breakaway Approved logo. Every contestant entering the approved roping will pay the \$10 nomination fee. (see above) Qualifiers are to be awarded to the overall FASTEST eligible time of the roping (not the average winners). A roper can only win ONE qualifier per event. A maximum of 4 qualifiers can be used at the Bonus Race World Finals BONUS BREAKAWAY. If a contestant maxes out earning 4 qualifiers, they are still eligible for the SEASON CHAMPIONSHIP buckle and \$250 cash credit in entry fees for the 2024 BRWF. This will be awarded to the contestant with the highest number of qualifiers earned in the season (July 1, 2023-April 1, 2024).

QUALIFIERS WILL BE ELIGIBLE FOR ENTRY IN THE BONUS BREAKAWAY AT THE 2024 BRWF (SHAWNEE, OK JUNE 16)

NO ADDITIONAL ENTRY FEE REQUIRED (ALL ROPERS WILL PAY 1X OFFICE FEE FOR FINALS EVENT)

GUARANTEED TO PAY A MINIMUM OF \$5000 FIRST (PLUS 3 OTHER PLACES MIN, TBD BY AMOUNT OF NOMINATION FUNDS COLLECTED). We will NOT move down the list if a roper is not able to attend. All qualifiers will have their name placed on our qualification list if a qualifier is earned.

BRWF24 Approved Event Qualifier Scale

1-10 entries = 1	11 – 25 = 2	26 – 40 = 3	41 – 55 = 4	56- 70 = 5
71 – 85 = 6	86-100 = 7	101 – 115 = 8	116 – 130 = 9	131- 145 = 10 etc.

AFTER YOUR EVENT (MUST RECEIVE WITHIN 10 DAY WITH PAYMENT)

*Return a copy of your complete results (we are flexible on format, but we need a copy to verify all results – handwritten is fine). For your convenience we have created timer sheets that are available on our website FREE for you to use.

*Return a RESULTS REPORTING FORM. This form should include winners' names, and cell phone numbers and their respective qualifying fast time. For your convenience, these forms are available on our website FREE for you to use.

Producers that fail to return results WITH PAYMENT within 10 days will not be eligible for future approval. It is important we receive results in a timely manner so that we can address any problems.
