



\*MINIMUM \$50 REQUIRED FOR ALL EVENTS (SINGLE OR SERIES) \*\*EVENTS WITH ENTRIES THAT FALL WITHIN 20 ENTRIES OF GIVING AN ADDITIONAL QUALIFIER WILL BE ALLOWED TO DO SO. IF YOU ARE WILLING TO PAY THE \$20 DIFFERENCE YOU MAY BUMP UP TO THE NEXT LEVEL. Sanction fee is \$1/run (with \$50 minimum) if your \$1/run fee is less than \$50 you must pay the difference to meet the \$50 min. NOTE – the \$1/run fee CANNOT be added to the entry. It should be taken off the top of the entry. All riders must pay the \$1/run fee (it is not optional) it is paidback 100% at our finals. In case of a tie for Bonus Qualifiers they should be handled the same as a tie (or split) for money would be handled.

SHOW APPROVAL REQUIREMENTS • TO BE APPROVED AN OFFICIAL APPROVAL FORM MUST BE FILLED OUT AND MAILED IN (WE PREFER MAIL WE ASK THAT THIS BE MAILED AT LEAST 30 DAYS IN ADVANCE AND WE PREFER 60 DAYS. TO BE A SINGLE QUALIFIER, RETURNING EVENTS MUST HAVE HAD CLOSE TO 100 ENTRIES IN THE PREVIOUS YEAR (75 OR MORE) AND HAVE AT LEAST \$250 ADDED MONEY. A \$50 MINIMUM sanctioning (APPROVAL) fee (after the show) IS ENFORCED FOR FOR ALL SINGLE EVENTS AND SERIES. IF YOUR EVENT DOES NOT HAVE 50 RUNS YOU WILL BE REQUIRED TO PAY THE DIFFERENCE TO MEET THE MINIMUM APPROVAL FEE REQUIREMENT. EVENT MUST BE OPEN TO EVERYONE AND NOT CHARGE A NON-MEMBER FEE. • PRODUCER MUST AGREE TO BE A GOOD PARTNER WITH BONUS RACE FINALS AND PLEASE ANNOUNCE QUALIFIERS WHEN READING RESULTS, POSTING THEM AT EVENT AND ONLINE AND HELPING US PROMOTE OUR EVENT AND FINALS • PRODUCER SHOULD MAIL OR EMAIL FULL RESULTS AT COMPLETION OF EVENT NOTING QUALIFIERS, ALONG WITH THEIR CITY AND STATE. (ADD MEMBERS INFO TO PRODUCER MEMBERSHIP LIST IF THEY ARE NOT IN THE COMPUTER) • A CHECK SHOULD BE MAILED WITHIN 10 DAYS OF YOUR EVENT TO BONUS RACE FINALS (PLEASE MAKE CHECK OUT THIS WAY!!) PO BOX 306 CHECOTAH OK 74426 WITH A RESULTS REPORTING FORM SO WE CAN KEEP TRACK OF WHICH EVENT YOU ARE REPORTING. DO NOT MAKE CHECK OUT TO ANY OTHER NAME MUST SAY BONUS RACE FINALS • PRODUCERS THAT DO NOT MAIL CHECKS WITHIN 10 DAYS OF COMPLETION OF EVENT MAY BE DENIED FUTURE APPROVALS AND/OR HAVE EVENTS REMOVED FROM THE CURRENT APPROVAL LIST. We reserve the right to refuse any approval for any reason. We are interested in working with positive, easy to get along with people that are willing to work together to promote the sport of barrel racing! Producers are encouraged to work together to not schedule on top of others events. No events will be approved during the World Finals, nor the Regional Finals Events. Thank you for your support, and we look forward to working with you this year!
